- Test and dispose soil in a recycling Approved Center.
- Building French drain to specification.
- Connect French drain to dedicated catch basin.
- Remove and dispose all debris resulting from construction-demolition.
- Repair and replace damaged wall components on a time and material basis. Please provide labor rate sheet, material receipts & contractor associated markup).
