## **GENERAL DESCRIPTION OF WORK**

The University is seeking to hire a Contractor for the work described below that will be delivered by Job Order Contracting (JOC) at the University of California, San Francisco Medical Center campuses at Parnassus Heights (Moffitt/Long Hospital, Ambulatory Care Center), Mount Zion (1600 Divisadero, 1545 Divisadero, 1701 Divisadero, 2255 Post, 2330 Post, 1675 Scott, 2356 Sutter), and at various leasehold spaces (2001 The Embarcadero, 1635 Divisadero, 2233 Post, 2320 Sutter, 2380 Sutter, 2655 Bush, 515 Spruce, 3575 Geary, 3360 Geary). Work under the JOC may include the following:
