

ADVERTISEMENT FOR BIDS

Sealed bids for a Lump Sum subcontract are invited from **Demolition** subcontractors (hereinafter "Subcontractors") for the following work:

PARNASSUS HEIGHTS CUP UREA SYSTEM**UCSF Project Number: PRJ-000327****Dome Construction Project Number: 230157**

The University has bid and awarded a CM at Risk Contract to Dome Construction Corporation (hereafter "CM/Contractor"). CM/Contractor is responsible for bidding and awarding all subsequent subcontractor packages, including this package. The successful Subcontractor Bidder shall sign a Subcontract Agreement directly with CM/Contractor and shall be bound by all the terms of the contract between University and CM/Contractor. **Refer to "University and CM/Contractor Prime Contract,"** which contains the contract between University and CM/Contractor, attached to the subcontract bidding documents and incorporated by this reference.

DESCRIPTION OF WORK:General Description:

The UCSF Parnassus Central Utilities Plant turbines, Turbine #1 and Turbine #2, which provide power to the Parnassus Campus utilize Selective Catalytic Reduction (SCR) systems which injects a liquid-reductant agent (currently ammonia) through a special catalyst into the exhaust stream of a diesel engine. This reduces levels of NOx by converting the pollutants into nitrogen, water and tiny amounts of CO2.

This project will replace the ammonia system with a urea system to achieve NOx reduction. After the urea injection installations have been completed, the ammonia storage building and tank located at the corner of Medical Center Way and Parnassus Avenue will be demolished. Conduits for controls and electrical wiring connecting the PCUP to the ammonia house will be abandoned, but may be reused in the future.

Bid Package: #5 Demolition (this contract):

This Bid Package consists of: Demolition of the infrastructure being abandoned within the ammonia house, surrounding hardscape, and ammonia tank.

The estimated construction cost of this bid package: \$308,900.

BIDDER QUALIFICATIONS:

To be eligible for consideration for award, bidders (Subcontractors) must meet the following minimum experience:

Subcontractors: Must have the minimum experience of successfully completing at least **(1) similar project**, or equivalent, of **\$300,000** construction contract amount or greater within the last 10 years of the bid opening date. All bidders must submit with their bid a completed Contractor's Statement of Experience (Exhibit 05) as an attachment to the Bid Form.

PROCEDURES:

Bidding Documents will be available to Subcontractor bidders week of May 13, 2024, on BuildingConnected.

A mandatory Pre-Bid Conference and mandatory Pre-Bid Job Walk will be conducted on May 16th, 2024, beginning promptly at 8:00 AM. Participants shall meet outside of 25 Medical Center Way, San Francisco, CA 94117. Only Subcontractor bidders who participate in both the Conference and the Job Walk in its entirety will be allowed to bid on the Project. BID DEADLINE: Bids will be received in BuildingConnected on or before 05/31/2024 at 2:00 p.m.

Bids cannot contain exclusions or qualifications. The Bidders must submit their Bids based on the project Bidding Documents only. Any proposed modification to the Bidding Documents must be submitted as a pre-bid RFI and distributed to all Bidders to be accepted. Bidders who qualify their Bids and are attached to Bid Form will not be accepted. Any qualifications attached to a Bid Form will be discarded as invalid. Subcontractor acknowledges this by submitting a Bid.

Prior to the Bid Deadline and after bid opening, Dome Construction and the University may establish a new Bid Deadline no earlier than 24 hours from the prior Bid Deadline, if no material changes are made to the bidding documents, and no earlier than 72 hours if material changes are made. In such event Dome Construction and the University will, at a minimum, notify all persons or entities known by Dome Construction and the University to have received a complete set of Bidding Documents and who has provided an electronic mail address for receipt of any written pre-bid communications.

Every effort will be made to ensure that all persons have equal access to contracts and other business opportunities with the University within the limits imposed by law or University policy. Each Bidder may be required to show evidence of its equal employment opportunity policy. The successful Bidder and its subcontractors will be required to follow the nondiscrimination requirements set forth in the contract between the University and the CM/Contractor, and to pay prevailing wage at the location of the work.

The work described in the contract is a public work subject to section 1771 of the California Labor Code.

No contractor or subcontractor, regardless of tier, may be listed on a Bid for, or engage in the performance of, any portion of this project, unless registered with the Department of Industrial Relations pursuant to Labor Code section 1725.5 and 1771.1.

This project is subject to compliance monitoring and enforcement by the Department of Industrial Relations.
