Removal of existing vacuum pump from Rock Hall Mechanical room mezzanine and replacement with new 20HP vacuum pump. Disconnect and reconnect plumbing and electrical. Anchor factory skid assembly to existing concrete deck. Provide startup and pass commissioning of vacuum pump.
